The entire event will be held at the Sheraton Grand Hotel in Sacramento, California - a perfect location for patients attending from all over the U.S.

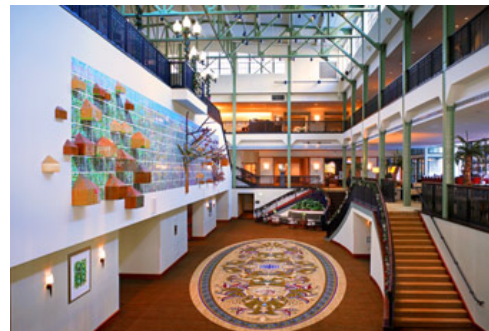
